- 3 Flooding. Anglian Water and the Environment Agency had replied to the letter sent to all agencies concerned with flooding problems in the village. Anglian Water maintains that flooding only occurs once in thirty years and, as their sewerage network can normally cope, they can offer no instant solution. The Environment Agency feels that this problem comes under the jurisdiction of either Anglian Water or WLDC, but they do exercise a general supervisory duty over all matters relation to drainage. It was AGREED we should wait a while and then contact the Environment Agency again to be an agenda item at the next meeting.
- 3 Road sweeping, The Crescent. Residents had been informed of the day that the road sweeper would come and they had moved their cars accordingly. It is hoped that the Clerk can be informed of future dates for road sweeping.
- 7 Street lighting along the bottom of High Meadows. No objections had been raised by residents; LCC Street Lighting team had been informed.
- 14 Provision of sand bags. The Church Commissioners have given permission for one of the barns at Manor Farm to be used for storing sand and sand bags, with the Flood Warden looking after them.
