1. ELECTION OF CHAIRMAN

Councillor Cooke proposed Councillor Scott continue as Chairman; seconded by Councillor Wall - AGREED. Councillor Scott signed the Declaration of Acceptance of Office.

2. ELECTION OF VICE CHAIRMAN

Councillor Wall proposed Councillor Cooke continue as Vice-Chairman; seconded by Councillor Canner - AGREED.

Councillor Wall proposed the Planning Committee be kept as in 2011/2012 - AGREED. Members are the Chairman, Vice Chairman, Councillor Patchett and Councillor Mrs. Howard.

Councillor Wall offered to continue as Play Area Inspector - AGREED.

(c) Police Liaison Officer

Councillor Cooke offered to continue as Police Liaison Officer - AGREED.

4. APOLOGIES FOR ABSENCE

There were no apologies for absence.

5. MEMBERS DECLARATIONS OF INTERESTS

No Declarations of Interest were made.

6. OPEN SESSION

There is a broken branch on the willow tree at the bottom of the allotment field. The Clerk to contact Mr. Walkinton and ask if he has any map/plans which will indicate ownership. The area will then be inspected.

There was considerable flooding near the Carpenters Arms during the recent heavy rain. Anglian Water is aware of the situation; the Clerk to ask LCC Highways to look into this problem.

A resident would like to see a night in the village hall for 16-19 year olds, and she is prepared to supervise. She was advised to contact the Village Hall Committee - Councillor Wall and Councillor Miss Chesman volunteered to get an emergency meeting of the Committee to discuss with all concerned.

The tarmac is sinking where the path joins the metal part of the Five Mile Bridge - the Clerk to inform the Environment Agency.

Part of Lincoln Road is sinking near the church opposite Blacksmith Road - the Clerk to inform LCC Highways. Lincolnshire Driveways have put up a sign on the junction of Hall Lane/Ferry Road - the Clerk to ask LCC Highways if it can be moved as it causes a danger to traffic

Building works at The Close have encroached onto the road verge on Chapel Lane - the Clerk to inform LCC Highways.

7. POLICE CONSTABLE'S REPORT

PCSO Ross Payne reported that the village is relatively quiet at present. Simple SID has been repaired and is now back on the village schedule. He then left the meeting.

18. OBSERVATIONS OF THE DISTRICT/COUNTY COUNCILLORS

District Councillor Darcel is prepared to print and distribute flyers for the Village Hall Jubilee Dance at Short Ferry. He reported that Nettleham Parish Council have negotiated a 14 year lease for the Old Bishops Palace from the Church Commissioners and wondered if we could do something similar for the Paddock field. He asked for assistance in inputting entries for the parish plan. It had already been AGREED that the Parish Council would pay for the printing of the questionnaires and he provided the meeting with three cheques for advertising (3 X £25) made payable to the Parish Council. He had paid for the printing himself and had kept advertising monies paid in cash; he agreed to provide the Parish Council with a bill for the rest of the printing costs - £75. AGREED that he would be paid this money.

County Councillor Fleetwood apologised for not attending the last meeting. He reported that the LCC Planning are not keen on any further extensions to the planning permission for the oil site works and that if the development is stopped the area needs to be returned back to farmland. He informed the meeting about the new National Planning Policy which came into effect in April, 2012 and which replaces all planning legislation. He can furnish copies if required. He was pleased that the road works outside 27 Ferry Road have finally been successful.
