He went on to say that JTP Architects who were the church commissioner developers (WYG) wanted an East West orientation. Both Derek Lawrence and Robert Lawton at West Lindsey District Council advised an East West orientation, which would provide 3 traffic access points instead of what was highlighted on a North South orientation.
